Answers:

- A. These robes are "personal", feminine garments and they are "highly appealing". Therefore, it is unfit for a woman to be seen dressed in such robes outdoors.
- B. "It is not refined and even distasteful to go out in the street dressed in it, because it shares a common name and basic characteristics with a night-robe."
- C. Wearing such a robe could involve the "issur" (wrongdoing) of causing others to stumble as it causes men to gaze at her or the dress.
- D. "Bringing the home out to the street" is a form of "pritzus" (breach in modesty) because by doing so, one is breaking the natural boundaries within which this garment is suitable to be worn.
- E. That because the general public is not used to seeing a woman dressed like this, to them it seems that she is wearing an elaborate night-robe. It is obviously not modest (to go in public) wearing a garment that gives the impression of being bedroom wear.
